## FERNHURST CEMETERY TABLE OF FEES AND OTHER CHARGES

1 AUGUST 2019

The undermentioned scale of fees and other charges were adopted by the Council on the 10 of July 2019 and are pursuant to Clause 15 (1) of the Local Authorities Cemeteries Order, 1977, a Statutory Instrument issued by the Secretary of State for the Environment under Section 214 (3) of the Local Government Act, 1972.

### IMPORTANT NOTE:

The fees, payments and other sums set out, apply where the person to be interred, or in respect of whom the right is granted, is or was immediately before death a parishioner or inhabitant of the Parish of Fernhurst or, in the case of a stillborn child, where either or both of the parents are so qualified either when the child was born or at the time of interment.

In all other cases: fees will be **doubled**.
